### What does JMS do with your personal information?

#### Why?

Financial companies choose how they share your nonpublic personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and transaction history
- Investment experience and assets
- Driver's license or government-issued ID
- Address or email
- Date of birth or death

#### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons JMS chooses to share; and whether you can limit this sharing.

<b>For nonaffiliates to market to you</b>	NO	We don't share

What we do	
How does JMS protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include physical, electronic and procedural safeguards, as well as restricting access to authorized personnel.
How does JMS collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>· open an account or update your contact information</li> <li>· direct us to buy or sell securities from your account</li> <li>· request a wire transfer or otherwise request deposits/withdrawals on your account</li> <li>· seek advice about your investments or tell us about your investment or retirement portfolio</li> <li>· give us your income information.</li> </ul> <p>We may also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>· sharing for affiliates' everyday business purposes— information about your creditworthiness</li> <li>· affiliates from using your information to market to you</li> <li>· sharing for nonaffiliates to market to you.</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
What happens after I am no longer a customer?	We may continue to share your information as described in this notice.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include companies with a JMS name, PWA Real Estate LLC, those with a "dba PWA" name, PWA Real Estate limited partnerships and other PWA real estate entities.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. JMS does not share with nonaffiliates so they can market to you.

To limit our sharing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. JMS doesn't jointly market.

State Laws	If you are a Vermont resident, we will automatically limit sharing of your information.
